

BAR POLICY 2020

In order to maintain compliance with the laws governing our Club's liquor license and to ensure the continued enjoyment of the members, the following policy has been implemented:

- THE SALE OF ALCOHOLIC BEVERAGES IS FOR MEMBERS AND THE GUESTS ACCOMPANYING THEM;
- The sale of liquor or wine for consumption outside of the Bar is prohibited;
- No one under 21 years of age will be served alcoholic beverages;
- Gambling is prohibited, if any form of money is involved (sports pools, cards, dice, etc.);
- Only members and their spouses are allowed behind the Bar at any time.

Restricted Access

- The Bar is a benefit of Club membership. Members are asked to produce a current membership card or picture ID to purchase their first drink.
- A "guest" is a person who is invited to the Club by a member and has been signed in by the member. When the Bar is open, all guests (over 21 years of age) are required to wear a wristband to identify them and enable them to purchase a drink. The member must be present at all times in order for the guest to purchase a drink.
- During social events the entire Club is closed to non-ticket holders. Wristbands will be provided to ticket holders for identification. Anyone without a wristband will be asked to leave. Boat owners and their guests are allowed access to their boats.

Beer Tap Honor System

- When the Bar is closed (no Bartender on duty), members may draw their own beer and donate the posted amount by placing it in the donation hole located to the right of the cash register.
- The posted donation amount is determined by the Bar Chairperson.
- Members may drink one draft beer per hour, free of charge, while performing work hours.
- On "Dock Days," members working on the docks may drink draft beer for up to two hours, free of charge, upon completion of the work day.
- Please do not abuse the honor system. It is a privilege.

Outside Alcohol

- Outside alcohol is NOT permitted on the entire second floor, including the decks, when the Bar is open (Bartender on duty).
- Outside alcohol is permitted when the Bar is closed (no Bartender on duty).
- During social events (when we have special permits) outside alcohol is NOT permitted in the entire facility with the exception of boats in the marina. Boats can only be accessed by boat owners and the guests accompanying them.
- Members who rent the hall are required to purchase alcohol through the Club. All outside alcohol is prohibited.

Bartenders

- No members, spouses or their children may be hired as Bartenders.
- In the event no Bartender is available, the Bar Chairperson may designate a qualified member to tend the Bar in exchange for work hours. Tips will be deposited in the donation hole.
